### USING CITY PROPERTY

In general, if you have questions about the use of City property – sidewalk, public lot, park, street, please email your question to Holly [hhansen@cloquetmn.gov](mailto:hhansen@cloquetmn.gov) and City staff will examine the use internally discuss and route the question.

- *If your project is selected/awarded a grant, and requires reservation of park space, only then will it be necessary to contact Community Ed to reserve Park Space by calling Lisa at 879-1261 or by [lneumann@isd94.org](mailto:lneumann@isd94.org)*
- *3<sup>rd</sup> parties are not covered by the city's insurance for using parks, so depending on the event type, insurance coverage may be important for you to obtain for your event.*

### USING PRIVATE PROPERTY – BUILDINGS / LOTS

If you're wondering about a building or business, **contact private building owners to discuss the use of their vacant storefront, windows, lot, private parking lot etc.**

- The city does not have tables or chairs available for use.
- The Cloquet Armory has some, but the city can't pull crews off of street jobs to deliver these, so folks would need to figure things out on their own. So best if someone needs tables, chairs and running water to find a building owner with space, see if they have access to those things (and their restrooms) to hold an event. **See attached contact list.**
